

## CONDITIONS OF ENROLMENT

- 1. All fees as indicated on your invoice are payable cash or via bank EFT to Sharkz Aquatics in advance, before the fifth of each month.
- 2. Full fees are payable during the swimming season. Please note that fees are worked out according to 10 lessons per term.
- 3. Please note that swimming continues termly according to the calendar set out by Sharkz Aquatics.
- 4. No fees will be returned for not-attendance -no matter the reason-
- 5. Once a single payment has been made, it is accepted that the terms and conditions of *Sharkz Aquatics* as set out in this document, are automatically accepted. You therefore agree to pay all charges including legal fees which may arise in the event that legal or other action is taken by *Sharkz Aquatics* to recover any fees or amount due, including, but not restricted to, collection commission, whether action is commenced or not.
- 6. If the swimming school is closed on Public Holidays, catch-up lessons will be allocated.
- 7. Swimmers must attend lessons equipped with a suitable swimming costume no bikinis and baggy shorts are permitted. Swimmers must supply their own towel, goggles cap and any other equipment specified for the particular program (fins, hand paddles)
- 8. Sharkz Aquatics will not be liable for the loss or misplacement of any articles belonging to the swimmer or any person entering the premises of 1/2 Acacia, Sea Park.
- 9. **TERMINATING LESSONS**: Membership shall continue for an indefinite period subject to one calendar month written notice, or one month's fees in lieu of notice to be paid on leaving the swimming school. All notices must be emailed or hand delivered to *Sharkz Aquatics* no later than the 1st day of your last swimming month. No telephonic or verbal notice will be accepted.



- 10. FITNESS TO PARTICIPATE: I declare that I am medically and physically fit and able to participate in the Swim Program. I will immediately notify the Sharkz Aquatics Operator of any change to my medical condition, fitness or ability to participate. I understand and accept that the Sharkz Aquatics Operator will continue to rely upon this declaration as evidence of my fitness and ability to participate in the Program.
- 11. MEDICAL TREATMENT: I consent to myself receiving any medical treatment that the Sharkz Aquatics Operator reasonably considers necessary or desirable for me during my participation in the Program. I also agree to reimburse the Sharkz Aquatics Operator for any costs or expenses incurred in providing me with medical treatment.
- 12.I Indemnify and hold blameless *Sharkz Aquatics*, its proprietors, employees, contractors and coaches and the owner of 1 / 2 Acacia, Sea Park, against any claims, loss or damages that I may suffer due to an injury, loss of or damage to property that I may suffer on the swim school premises.
